Under the direction of Prime Minister Stephen Harper, the Conservative government passed the Federal Accountability Act at the beginning of 2007.

This act placed new limits on political donations to ensure greater transparency and accountability.

Only Canadian citizens or permanent residents of Canada are allowed to make donations. Donations from corporations, trade unions, and unincorporated associations are prohibited.

You can donate a maximum of \$1100 per year to your local electoral district association (EDA).

You can also donate a maximum of \$1100 per year to the National Party through the Conservative Fund.

Donations made to the National Party do not flow to your local EDA. If you want to help us mount a successful campaign in St. Paul's, I encourage you to

make donating to St. Paul's Conservative EDA your top priority.

Donations are eligible for a tax credit. The size of the tax credit depends on the amount donated and not on your taxable income. To receive your credit, you simply have to file a tax return.

To ensure you receive your maximum credit, donate to St. Paul's Conservative EDA every year. For your convenience, you can authorize an automatic monthly donation.
